#### **APPLICABILITY**

This rate schedule applies to low-power electric service for customer-owned equipment installed on a Company-owned or joint-use pole where 120V distribution is already installed and where type service required is limited to the following:

- 1. single-phase, 120V, 2-wire service,
- 2. no more than 50 watts (or 0.5 Amps) of connected load per service point, and no more than 36 kWh of consumption per month

A pole-attachment agreement with the Company for all facilities attached to a Company-owned pole is required. All facilities regardless of pole ownership must meet company distribution construction specifications.

## AVAILABILITY AND KIND OF SERVICE

Service under this rate schedule is available on uniform basis throughout service territory of Company where existing 120V secondary voltage is available on the pole. The kind of service under this schedule shall be single-phase, 2-wire, at 120V nominal service voltage available from Company's distribution system serving the area.

Electric Service under this rate schedule is premised on the availability of distribution facilities serving other General Service customers. Where additional facilities must be installed to specifically serve the customer, the customer may be required to pay for the additional capital facilities and perpetual maintenance thereof. Service at any other voltage shall be made available only at option of Company.

Unmetered service is not available for existing service points that are currently metered regardless of capacity requirements. Electric Service requiring more than 50 Watts of capacity or more than 36 kWh of consumption per month will be served under another applicable rate schedule. Company reserves the right to install load metering equipment to verify consumption.

#### **Demand and Energy**

Charge per month for each service point with a maximum rated demand of up to 50 Watts max power and consumption of 36 kWh/month

\$5.10

Monthly billing demand and energy consumption for each service point will be based on continuous power operation and reflect the maximum kW and kWh values shown in Monthly Rate for Service. Service points served in the same local sales taxing area may be aggregated and billed under the same bill account. Service points served in separate local taxing areas will be separately billed.

## MINIMUM MONTHLY BILL

In consideration of readiness of Company to furnish service under this rate schedule, no monthly bill will be rendered for less than the base charge; plus, the Demand and Energy charges.

#### **FUEL COST RECOVERY CLAUSE**

To total of above charges for electric service under this rate schedule, there shall be added an amount determined in accordance with provisions of Company's Fuel Cost Recovery Clause Schedule on file with and approved by the Mississippi Public Service Commission.

## **MISCELLANEOUS RATE ADJUSTMENTS**

To the total of all the above charges for electric service under this rate schedule, there shall be added or subtracted any amounts determined in accordance with clauses or plans filed and in effect with the Mississippi Public Service Commission.

#### **TAX CLAUSE**

To the total of all of the above charges for electric service under this rate schedule, there shall be added applicable existing Mississippi state and municipal sales taxes, and any new or additional tax or taxes, or changes in rates of existing taxes, imposed after effective date of this rate schedule by any governmental authority upon service rendered by Company hereunder.

## **ORDER OF BILLING**

Charges are applied in the sequence they appear in rate schedule: Monthly Rate for Service, Minimum Monthly Bill, Fuel Cost Recovery Clause, Miscellaneous Rate Adjustments, and Tax Clause.

## **PAYMENT**

Bills rendered under this rate schedule are payable on receipt.

## **DEPOSIT**

A cash deposit equal to twice estimated maximum monthly bill may be required of customer before service is connected to guarantee payment of all bills.

#### **TERM OF CONTRACT**

Minimum term of service to an establishment under this rate schedule shall be twelve (12) months and continuing thereafter until terminated by three months' written notice by either party to other.

Service under this rate schedule is subject to service rules of Company.
